Great Northern Services collaborates with existing holiday basket programs across Siskiyou County. Through this partnership, we aim to ensure that families can enjoy a festive and hearty meal during the holiday season.

#### School Mini Pantries—100% donations

Because empty stomachs shouldn't hinder a child's ability to learn and grow, these pantries serve a crucial purpose, allowing teachers to provide snacks to hungry students during the school day. Additionally, teachers can prepare take-home bags, ensuring that children have enough to eat over the weekends. By addressing this basic need, we're empowering students to focus on their education, fostering an environment where learning and growth can flourish. Our partners, the Mt Shasta Rotary and the Weed Rotary, delivers to the schools in South Siskiyou County and our goal is to have pantry in all schools in Siskiyou County. This program started in 2018.

#### Snack Bags—100% donations

We introduced the program in 2017 to support families facing financial strain during school breaks. We purchase and deliver healthy snacks to schools in Weed, Dunsmuir, Mt. Shasta, and McCloud, where almost 90% of students rely on free or reduced lunch programs. This program not only ensures children have nutritious food during breaks but also eases the burden on low-income families, offering them a helping hand when they need it most.

#### South Siskiyou Senior Nutrition—50% donations

We operate a Community Café in South Siskiyou County since 2019, providing a welcoming environment for both seniors and non-seniors to enjoy communal meals. The café is located at the Mt. Shasta City Park. Additionally, we offer Home Delivered Meals to eligible seniors in the South County communities based on specific criteria. Our meals are carefully crafted, focusing on balanced nutrition to ensure the well-being of our community members. We understand the importance of catering to diverse dietary needs, and therefore, our menu includes options suitable for individuals following specific diets such as diabetic or gluten-free diets. Great Northern Services operates this program which is funded under the Older Americans Act through PSA 2 Area Agency on Aging and the California Department of Aging.

#### **USDA Food Commodities**

Great Northern Services holds a special designation from both the State of California and the Siskiyou County Board of Supervisors, empowering us to distribute USDA Commodities and emergency food supplies within our communities. We partner with 21 food pantries in the county.
